On behalf of the Pondicherry Municipal Council sealed Item rate e-tenders are invited from eligible contractors / firms who are registered with Public Works Department, Puducherry as class mentioned in the column 7 of the Table below. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for e-tenders. Tender Schedule can be downloaded and submitted online through the website https://pudutenders.gov.in only by those contractors, who are having valid ikey and Digital Signature Certificate and the tender Schedules cannot be purchased from the Office of the Executive Engineer Pondicherry Municipality by remitting the cash in the Office of the Executive Engineer and no pre request for issue of tender schedules will be entertained in the office of the Executive Engineer.

3. Submission of EMD and cost of Tender Documents should be credited as detailed below:

The contractor shall remit EMD and cost of tender schedule on or before the closing date and time for submission of e-tender through online by Internet Banking or NEFT/RTGS modes. In Internet banking, bidders shall make payments using his/her Internet Banking enabled account with any of the banks listed in the Annexure enclosed. The payment Gateway will display a list of banks wherein the bidder has to choose his/her bank. Upon selection, the bidder will be taken to the login page of his/her bank. The bidder has to login and proceed for paying the Tender fees/EMD. If the transaction is successful, system will be redirected to the e-Tendering portal for submission of bid.

To facilitate Bidders who do not have Internet banking facility, payment can be made offline through EFT/RTGS mode. In this option, the bidder has to take print-out of the NEFT/RTGS payment Challan auto-generated Jy the system and visit his/her bank to remit the requisite amount. Once payment is received in the pooling account the bidders will be able to proceed for bid submission by feeding the Unique Transaction Reference (UTR) number in the e-procurement portal. It is advised that the bidders make payment one day in advance for validation purpose. ICICI Banks shall handle the queries of the bidders regarding online payment.

4. On the scheduled Time and date of opening, the Commissioner Pondicherry Municipality authorizes the opening of e-tender on the notified time. Contractor can access the particulars, after opening of e-tender in the website. The Municipality will not be liable for any delay in submission of e-tender.

5. The Contractor / Contracting finn should enclose a copy of the certification of registration issued by the "Employees' provident Fund Organization" along with EMD in the technical bid, in the form of Scanned copy otherwise no payment will be made to the bill under consideration.

6. A Copy of the enlistment of contractor license issued by the competent authority (i.e.) Copy of Registration should be scanned and uploaded.

7. For Contractors other than those registered in PWD. Puducherry should produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed works of magnitude specified in the first paragraph of this Tender Notice. The scanned copy of the proof should be uploaded.

8. The contractor should submit a self-declaration showing the details of work on their hand in the form of scanned copy.

9. The time allowed for carrying out the work as noted in column No.8 of the table above will be including mensoon period.

10. If the last date of opening day of tenders happens to be Public Holiday the same will be opened on next working day.

11. The Commissioner Pondicherr Municipality reserves the right to reject any or all the tenders without assigning any reason thereof.

12. This work is covered under Puducherry Goods and Services Tax Act 2017 and hence the contractors are requested to quote the rates including the effect of GST. Additional / Separate claim for GST will NOT be entertained on any account after the award of work. The payment is also liable for TDS as instructed by the Commercial Tax Department based on GST.
