The committee complied, but subject to the condition, it should in no way affect the functional aspect of ladies toilet and its privacy and also no damage to be caused to the existing structure.
3.	The participant requested for projections on the Eastern and Southern side of the building to have a sea view walk way in his proposal.	The committee clarified that the same may be allowed subject to the scrutiny of the drawings presented, based on the PPA and other local regulations. (It must be in temporary structure).
