## TERMS AND CONDITIONS:

- 1. Registered firm/NGO/Agency/Company/Society who are running their business in the Collection and Transportation of Construction and Demolition Waste in Puducherry U.T and are willing for Collection and Transportation of Construction and Demolition Waste at the identified location as directed by the Competent authority of the Pondicherry empanelment.
- 2. Willing applicants has to submit the application in physical form in the box provided in the office of the Commissioner, Pondicherry Municipality in a sealed envelope superscribed on the top as " Empanelment of Service providers for Collection, Transportation of Construction and Demolition Waste" on or before 11.12.2019 at 5.00 pm, failing which the application will be summarily rejected.
- 3. The applicants has to submit a Security Deposit to an amount of Rs.25,000/-(Rupees Twenty Five Thousand only) in the form of Demand Draft drawn in any of the Nationalised Bank in the name of "The Commissioner, Pondicherry Municipality" payable at Puducherry along with the application.
- 4. The issuance of this EOI does not imply that Pondicherry Municipality is applicant. The Commissioner, bound to select or to empanel the Municipality reserves the rights to cancel this call for Puducherry expression of interest for administrative reasons without assigning any reasons thereof. The purpose of this EOI is to make known to public about the availability of the service providers in the field of Collection and Transportation of Construction and Demolition Waste as per Construction and Demolition Waste Rules 2016.
- 5. Empanelled List of service providers will be published in Pondicherry Municipality website/press media. Empanelled service providers are expected to attend Govt./municipal/public call for their service. The Pondicherry Municipality is not in anyway connected with the service of the service providers and this EOI do not confer any right to the Empanelled Service Providers on Pondicherry Municipality for their service.
- 6. The payment for unloading the construction and demolition waste in the identified location will be fixed by the competent authority of the Municipality and will be communicated in the letter of intimation to the empanelled service providers.

- 7. The selected applicants for empanelment should adhere to the payment for unloading the Construction and Demolition waste as fixed by the Municipality in the identified location as per Construction and Demolition Waste Rules 2016 without any conditions or otherwise the Security Deposit will be summarily forfeited without any prior notice.
- 8. The Security Deposit submitted by the selected applicant will be refunded only at the end of empanelment period of 1 (one) year or extended period, if any, from the date of actual intimation after deducting payment dues or applicable deductions, if any. No interim refund of security deposit will be made to the applicant. Extension of period will be made only at the discretion of the Competent Authority of the Pondicherry Municipality.
- 9. The Security Deposit of the unsuccessful applicants who are not empanelled will be refunded.
- 10. The Municipal Authorithy has full rights to delete any empanelled applicant from the empanelled list of service providers without assigning any reasons thereof.
- 11. Applications which are not satisfying the terms and conditions will be summarily rejected by the undersigned at any time without assigning any reasons thereof. The applicants has to obtain necessary permissions/orders, if any required from other departments as per law for carrying out this business at their own cost and risk.
